Social members of the RCNSW will have their social membership cancelled and/or be requested to upgrade their membership to full membership rights, if it is found that: they have any purebred Rottweiler on Main Register; and/or their Rottweiler is not desexed; and/or they have bred a litter since joining the RCNSW as a social member; and/or they have entered conformation shows since joining the RCNSW as a social member as such owners are required to apply for 'full membership' with the RCNSW because if they breed and/or show Rottweilers, or have the ability to do so, then they should conform to the Code of Ethics.
